Minutes of a work session of the Town Board of the Town of Somers held on Thursday evening May 1, 2014 at 6:15 PM at the Town House, 335 Route 202, Somers, New York.

DOES HEREBY, authorize the Building Inspector to request proposals for a 2014 Chevrolet Four Wheel Drive Equinox.

Thereupon motion Supervisor Morrissey, seconded by Councilman Clinchy, it was unanimously,

RESOLVED, that the Town Board does hereby authorize the Historical Properties Board to solicit Request for Proposals (RFP) for the Mt. Zion Church pending approval of the project by the Historical Properties Board.
